Funded Early Education and Childcare Entitlements **Working Family Entitlement – 9 Months to 4 Years Old**

Eligible children aged 9 months up to 4 years old from working families are entitled to:

- 1,140 funded hours per year
- Equivalent to:
 - 30 hours per week (term time only), or
 - 21.92 hours per week (stretched across the year)

Early Learning Entitlement – 2 Year Olds

Eligible 2-year-olds are entitled to:

- 570 funded hours per year
- Equivalent to:
 - 15 hours per week (term time only), or
 - 10.96 hours per week (stretched across the year)

Children can access this entitlement from the start of the term following their 2nd birthday.

Universal Entitlement – 3 and 4 Year Olds

All 3- and 4-year-olds are entitled to:

- 570 funded hours per year (Universal 15 hours)
- Equivalent to:
 - 15 hours per week (term time only), or
 - 10.96 hours per week (stretched across the year)

Eligibility is based solely on date of birth.

Children can access this entitlement from the start of the term following their 3rd birthday.

4. Notice Period

From April 2026, Durham County Council are implementing a policy of allowing EY providers to request a maximum of 4 weeks' notice for a funded child wishing to move from one registered setting to another registered setting. We are unable to double fund a child at two providers or pay a provider twice for the same place. However, we recognise that it might take some time to fill an empty place, so we are implementing a maximum four weeks' notice period funding policy where a place is empty, and while a child is in this notice period they cannot be funded at a new provider.

Parents/carers are reminded of their responsibility to give a maximum of four weeks' notice on their child's funded hours – if this is not adhered to then you may be subject to a charge from your funded child's current EY setting. It is recommended that you speak to your EY setting before deciding to move your child to another registered setting.

I agree that on a future date (if applicable) that I will give at least 4 weeks' notice at my child's registered setting if my child moves on to another registered setting.

5. Disability Access Fund

If your child is receiving child Disability Living Allowance and is receiving the free entitlement, he or she is eligible for the Disability Access Fund (DAF). DAF is paid to your child's early year's provider. The purpose of DAF is to support providers to make reasonable adjustments to your child's provision.

Government funding is intended to deliver 15 or 30 hours per week (term time equivalent) of free, high quality, flexible early years education and care. This 15 or 30 hours must be able to be accessed free of charge to parents, that is, there must not be any mandatory charges for parents in relation to the entitlement hours.

Government funding is not intended to cover the costs of meals, other consumables, additional hours or additional services. Providers can charge for consumables, meals and snacks, extra activities and additional hours provided they are not mandatory charges or a condition of accessing a place.

The costs of chargeable extras should be published on provider websites or, where they do not have any website, on Local Authority Family Information Services. These should be clear, up-to-date and easily accessible to parents, to enable parents to make an informed choice of provider.

Providers should give details of the charges made for consumables and additional services, itemised details of what these charges relate to should be proportionate, but enable the parent/carer to understand the charges they are agreeing to by completing the section below.
